Regulatory Update

There has been a great deal of focus in January and February regarding the EMA access to clinical trial data initiative. As noted in the December 2012 newsletter, EMA have set up 5 advisory groups on the following topic areas: patient confidentiality; clinical trial data formats; rules of engagement; good analysis practice; and legal aspects. Each group will meet 3 times between January and March after which EMA will develop recommendations by the end of April. Following consultation and review during the summer, final guidance is anticipated by the end of 2013.

EFPIA have also set up working groups on these 5 topic areas. EFSPI have representation on 4 of the EMA advisory groups and EFPIA working groups. There are a number of important aspects under discussion, including who should have access to clinical trial data, how should data be made available, what data should be made available, and most importantly how will patient confidentiality be maintained. Stefan Driessen (stefan.driessen@abbott.com) is the EFSPI contact for 'patient

confidentiality'; Uli Burger (<u>hans_ulrich.burger@roche.com</u>) is the EFSPI contact for 'clinical trial data formats'; Chrissie Fletcher (<u>fletcher@amgen.com</u>) is the EFSPI contact for 'rules of engagement'; and Christoph Gerlinger (<u>christoph.gerlinger@bayer.com</u>) is the EFSPI contact for 'good analysis plans'. Each EFSPI lead is engaging with other statisticians who are participating in the advisory/working groups and with the EFSPI Statistical Leaders to discuss the key statistical aspects. EFSPI will be developing a position and recommendations on these topics and we will share this in a future newsletter.

Association of the month: Italy and BIAS

The Italian association BIAS (Biometristi dell'industria Farmaceutica Associati) is organizing two events in 2013 in an effort to reach both Italian Statisticians working in the healthcare industry, and also Clinical Data Managers, SAS programmers and other roles involved in clinical research such as Quality Assurance Managers and Clinical Study Managers. As 213 is the International Year of Statistics, the BIAS group wants to promote biostatistics and increase public awareness on its importance in clinical research.

On February 22nd, the BIAS committee is organizing a conference titled "Data Handling and Reporting in Clinical Trials with SAS". This conference covers various aspects of statistical analysis in a clinical study from a SAS programming point of view. The topics covered will focus on using data standards, the use of SAS procedures for statistical modeling, the different techniques for reporting and the strategies and techniques for QC. This is an opportunity for professionals in the industry to share experiences, challenges and solutions.

The second event of the year will be the 5th Annual BIAS Congress in September. Having great success and positive feedback in previous years, BIAS will again organize two parallel sessions joining the Biostatisticians and the Data Managers. Details on the program are still being defined, but the congress will be related to recent issues and trends in Clinical Data Management and Biostatistics. Probable topics include subgroup analysis, Bayesian methods, simulation methods and submission requirements (CDISC).

- *Health Technology Assessments on June 4, 2013 in Basel*. This joint meeting with the BBS will highlight, together with case studies, some of the key statistical challenges by representatives from academia, HTA bodies/regulators and industry.
