Regulatory Update

EMA published its draft policy on publication and access to clinical trial data for consultation on the 24th June 2013 and comments are due by September 30th 2013. EFSPI has issued a position paper on EMA's data transparency initiative and will be submitting comments on the draft policy on behalf of the EU Statistical community. The comments are currently being collated within each EFSPI member association.

EFSPI / PSI are hosting a *European statistical workshop on Thursday 22nd August 2013 at the Royal Statistical Society (RSS) in London* to discuss key elements of the draft policy. Various speakers will highlight key challenges in this area from different angles to stimulate the discussion in breakout sessions. EU Statistics Leaders Meeting

The fourth EFSPI Statistical Leaders meeting was held June 18, 2013, in Copenhagen, Denmark. Twenty-three leaders from 9 different countries and 20 pharmaceutical companies attended. The strategic objectives for EFSPI for 2013-2015 were presented followed by several sessions on Special Interest Groups (SIG). The new SIG Medical Devices was introduced with a useful summary of recent changes and trends in this area with opportunities for statisticians and EFSPI to contribute to the developing regulatory framework and to develop collaboratively good statistical practice in Medical Devices. The Benefit Risk SIG presented on the progress since the last meeting with the development of a roadmap describing and linking in to the numerous Benefit-Risk initiatives currently underway. The session was closed by an overall update on all SIGs from which it became clear that there is a significant amount of important activities underway, including meetings, useful handbooks and best practice documents.

The EMA's Clinical Trial Data Transparency initiative was extensively discussed: status updates were provided on emerging trends by the regulators including EMA and FDA, and emerging positions by Industry Associations including EFPIA and EFSPI were summarised; Two companies, GSK and Roche, shared details of their company strategies with regard to transparency; and four breakout sessions elaborated on what impact transparency is anticipated to have on the EU statistics community in the future. The general message of the Statistical Leaders to EFSPI was that it should focus on good statistical principles and seek opportunities to highlight these. Ideally EFSPI should strive to develop one industry position on the important principles regarding access to data and data anonymisation. Furthermore, it would be good for EFSPI to consider developing or collaborating on guidance for secondary and/or re-analysis of study results. Finally, the Statistics Leaders acknowledged transparency is a new and important area for the statistics community, which will bring challenges and opportunities.

SIG Update

EFSPI are pleased to announce the formation of a new SIG on *Integrated Data Analysis*. The new SIG will be led by Byron Jones from Novartis, Basel, and has the following aims:

- 1. To create a forum for individuals interested in integrated data analyses to share experiences, develop best practices, work with experts in the field and collaborate with other interested parties on integrated data analysis in drug development.
- 2. To be aware of regulatory initiatives of relevance to integrated data analysis and to assess their potential impact on industry practice.
- 3. To develop an industry position on how data in the private and public domains should be integrated and presented, particularly with respect to how such data will be considered by regulatory agencies.
- 4. To form working groups to review current methodology and practice, and where necessary develop new methods or practices for the integration of data, in the areas of
 - a. Efficacy Data in Phases II and III;
 - b. Safety Data (maintaining links with the Epidemiology and Safety SIG);
 - c. Health Technology Assessment and Network Meta-Analysis (maintaining links with the Health Technology Assessment SIG);
 - d. Trial results made public as a result of greater data transparency on the part of the industry.
- 5. To write position papers on the topics identified in 4. and engage in public debate by making presentations at public meetings and conferences.

Association of the month: FMS (Föreningen för Medicinsk Statistik)

The Swedish Society for Medical Statistics, FMS (Föreningen för Medicinsk Statistik) is a subsection of the Swedish Statistical Society (Svenska Statistikfrämjandet), an association for all fields of statistics and statisticians: medicine, industry, surveys and official statistics, education and research. Statisticians as well as users of statistics and other "friends of statistics" are welcome as members.

FMS organizes statisticians within the medical area, i.e. in the pharmaceutical industry as well as in other medical research, public or private, and in biostatistical research and education. The main objective of FMS is to stimulate the development and promote the use of new and established statistical methods within the medical sector as well as within the areas of pharmaceutical industry and public health.

To achieve this, FMS organizes courses and scientific meetings, typically 2-4 meetings each year. Regular such meetings are the combined spring/annual meeting and a fall meeting. Every other year we co-organize meetings with our sister-associations in Denmark (DSBS) and Finland (SSL). The most recent collaborations were a workshop on Bayesian data analysis in Espoo, Finland, organized together with SSL this year, and a workshop in Malmö (Sweden) 2012 on Benefit-risk assessment methodology organized together with DSBS and EFSPI. In addition to organizing meetings, FMS distributes information on scientific meetings, courses, EFSPI information etc. FMS also promotes discussions on applications or statistical issues through articles in Qvintensen, a quarterly magazine published by the Swedish Statistical Society.

FMS has almost 300 members and was founded in 1987; we recently celebrated our 25th anniversary.
