EFSPI Council News

The EFSPI Council had a teleconference meeting on the 1st March 2012. The EFSPI constitution was reviewed and updated.

The "Who's EFSPI" slide deck is available on the EFSPI website <u>www.efspi.org</u>. The information provides a summary of the mission and vision of EFPSI, which country associations are members of EFSPI, who sits on the Council and the specific roles individuals have which support EFSPI.

In late 2011, EFSPI along with PSI have initiated a new collaboration with a US-based Statistics group, QSPI. QSPI stands for 'Quantitative Sciences in the Pharmaceutical Industry'. They are associated to the Society of Clinical Trials (SCT) and were previously known as the PhRMA BDMTG (Biostatics and Data Management Technical Group). EFSPI and QSPI are keen to identify areas for collaboration, for example, engaging in the review or new or updated regulatory guidelines. A representative from QSPI will participate in the next EFSPI Council meeting and provide an update on the key goals and activities QSPI will be focusing on in 2012.

Also in late 2011, EFSPI along with PSI have initiated a new collaboration with ISPOR, the International Society of Pharmacoeconomics and Outcomes Research. There are ongoing discussions to identify opportunities for the societies to collaborate, which could include areas relating to scientific meetings and training courses. The HTA SIG has been working with some ISPOR members on specific activities. This outreach by EFSPI and PSI to ISPOR is aimed at seeking areas of mutual interest across both societies given the increased collaboration in Pharmaceutical companies between Health Economics/Outcomes Research and Biostatistics disciplines. More details will follow in future newsletters.

Carl-Fredrik Burman (FMS representative) has stepped down from the council after serving 7 years. EFPSI greatly appreciates the contributions Carl-Fredrik has made over this significant time period. John Adler will be replacing Carl-Fredrik. EFSPI would also like to thank the contributions of Fransseca Patarnello (BIAS) and Tom Loes (SBS/BVS) who also have stepped down from the Council, and welcome their replacements, Giampaolo Giacovelli and An Vandenbosch respectively.
