Please join me in congratulating Justine Rochon on her new role as our EFSPi president!

Justine took over the EFSPi presidency in January 2022 after contributing to the federation for 5 years in different roles, lastly as chair of EFSPi statistics leaders. - Position EFSPI in the Data Science arena and provide guidance to statisticians working in this area of pharmaceutical industry
